VOTING ELIGIBILITY

The Directors have determined pursuant to Regulation 7.11.37 of the *Corporations Regulations 2001* (Cth) that the persons eligible to vote at the Meeting are those who are registered Shareholders at 10.00am (WST) on Sunday, 23 November 2025.

VOTING IN PERSON

To vote in person, attend the Annual General Meeting at the time, date and place set out above.

VOTING BY PROXY

To vote by proxy, please follow the instructions set out on the Proxy Form accompanying this Notice.

In accordance with section 249L of the Corporations Act, Shareholders are advised that:

1. FINANCIAL STATEMENTS AND REPORTS

To receive and consider the annual financial report of the Company for the financial year ended 30 June 2025 together with the declaration of the Directors, the Director's report, the Remuneration Report and the auditor's report.

2. RESOLUTION 1 – ADOPTION OF REMUNERATION REPORT

To consider and, if thought fit, to pass, with or without amendment, the following resolution as a **non-binding resolution**:

"That, for the purposes of section 250R(2) of the Corporations Act and for all other purposes, approval is given for the adoption of the Remuneration Report as contained in the Company's annual financial report for the financial year ended 30 June 2025."

Note: the vote on this Resolution is advisory only and does not bind the Directors or the Company.

Voting Prohibition Statement:

The Company will disregard any votes cast in favour of this Resolution:

- (a) by or on behalf of a member of the Key Management Personnel, details of whose remuneration are included in the Remuneration Report, or their Closely Related Parties, regardless of the capacity in which the votes are cast; or
- (b) by a person who is a member of the Key Management Personnel at the date of the Annual General Meeting, or their Closely Related Parties, as a proxy.

However, votes will not be disregarded if they are cast by a person (the **voter**) as a proxy for a person entitled to vote on this Resolution and either:

- (c) the voter is appointed as a proxy by writing that specifies the way the proxy is to vote on this Resolution; or
- (d) the voter is the Chair and the appointment of the Chair as proxy:
 - (i) does not specify the way the proxy is to vote on this Resolution; and
 - (ii) expressly authorises the Chair to exercise the proxy even though this Resolution is connected directly or indirectly with the remuneration of a member of the Key Management Personnel.

3. RESOLUTION 2 – RE-ELECTION OF DIRECTOR – MR MARK CLARK

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

"That, for the purposes of ASX Listing Rule 14.4, rule 11.7(a) of the Constitution and for all other purposes, Mr Mark Clark, a Director, retires by rotation, and being eligible, is re-elected as a Director."

4. RESOLUTION 3 – RE-ELECTION OF DIRECTOR – MR MYLES ERTZEN

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

"That, for the purposes of ASX Listing Rule 14.4, rule 11.7(a) of the Constitution and for all other purposes, Mr Myles Ertzen, a Director, retires by rotation, and being eligible, is re-elected as a Director."

5. RESOLUTION 4 – RATIFICATION OF PRIOR ISSUE OF SHARES

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

"That, for the purpose of ASX Listing Rule 7.4 and for all other purposes, Shareholders ratify the issue of 17,721,519 Shares to Macquarie Bank Limited on 18 March 2025 at an issue price of \$7.90 per Share in connection with the closure of gold forward sale hedge contracts and the purchase of gold put options, on the terms and conditions set out in the Explanatory Statement."

Voting Exclusion:

The Company will disregard any votes cast in favour of this Resolution by or on behalf of:

- (a) Macquarie Bank Limited; or
- (b) an associate of Macquarie Bank Limited.

However, this does not apply to a vote cast in favour of this Resolution by:

- (c) a person as proxy or attorney for a person who is entitled to vote on this Resolution, in accordance with directions given to the proxy or attorney to vote on this Resolution in that way; or
- (d) the Chair as proxy or attorney for a person who is entitled to vote on this Resolution, in accordance with a direction given to the Chair to vote on this Resolution as the Chair decides; or
- (e) a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary provided the following conditions are met:
 - (i) the beneficiary provides written confirmation to the holder that the beneficiary is not excluded from voting, and is not an associate of a person excluded from voting, on this Resolution; and
 - (ii) the holder votes on this Resolution in accordance with directions given by the beneficiary to the holder to vote in that way.

6. RESOLUTION 5 – APPROVAL OF ISSUE OF PERFORMANCE RIGHTS TO MR MARK CLARK

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

"That, for the purposes of ASX Listing Rule 10.14, sections 200B and 200E of the Corporations Act and for all other purposes, Shareholders authorise and approve the issue of 170,395 Performance Rights under the Performance Rights Plan by the Company to Mr Mark Clark, a Director of the Company, or his nominee, on the terms and conditions described in the Explanatory Statement."

Voting Exclusion:

The Company will disregard any votes cast in favour of this Resolution by or on behalf of:

- (a) a person referred to in ASX Listing Rule 10.14.1, 10.14.2 or 10.14.3 who is eligible to participate in the employee incentive scheme in question; or
- (b) an associate of that person or those persons.

However, this does not apply to a vote cast in favour of this Resolution by:

- (c) a person as proxy or attorney for a person who is entitled to vote on this Resolution, in accordance with directions given to the proxy or attorney to vote on this Resolution in that way;
- (d) the Chair as proxy or attorney for a person who is entitled to vote on this Resolution, in accordance with a direction given to the Chair to vote on this Resolution as the Chair decides; or
- (e) a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary provided the following conditions are met:

- (i) the beneficiary provides written confirmation to the holder that the beneficiary is not excluded from voting, and is not an associate of a person excluded from voting, on this Resolution; and
- (ii) the holder votes on this Resolution in accordance with directions given by the beneficiary to the holder to vote in that way.

Voting Prohibition Statement:

As required by section 200E of the Corporations Act, a vote on this Resolution 5 must not be cast (in any capacity) by or on behalf of Mr Clark or any of his associates. However, this prohibition does not apply if:

- (a) the vote is cast by a person as proxy appointing in writing that specifies how the proxy is to vote on this Resolution; and
- (b) the vote is not cast on behalf of Mr Clark or any of his associates.

Further, a person appointed as a proxy must not vote, on the basis of that appointment, on this Resolution if:

- (a) the proxy is either:
 - (i) a member of the Key Management Personnel; or
 - (ii) a Closely Related Party of such a member; and
- (b) the appointment does not specify the way the proxy is to vote on this Resolution.

However, the above prohibition does not apply if:

- (c) the proxy is the Chair; and
- (d) the appointment expressly authorises the Chair to exercise the proxy even though this Resolution is connected directly or indirectly with remuneration of a member of the Key Management Personnel.

EXPLANATORY STATEMENT

This Explanatory Statement has been prepared to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the Resolutions.

1. FINANCIAL STATEMENTS AND REPORTS

In accordance with the Constitution, the business of the Meeting will include receipt and consideration of the annual financial report of the Company for the financial year ended 30 June 2025 together with the declaration of the Directors, the Directors' report, the Remuneration Report and the auditor's report.

The Company will not provide a hard copy of the Company's annual financial report to Shareholders unless specifically requested to do so. The Company's annual financial report is available on its website at www.capmetals.com.au.

2. RESOLUTION 1 – ADOPTION OF REMUNERATION REPORT

2.1 General

The Corporations Act requires that at a listed company's annual general meeting, a resolution that the remuneration report be adopted must be put to the shareholders. However, such a resolution is advisory only and does not bind the company or the directors of the company.

The remuneration report sets out the company's remuneration arrangements for the directors and senior management of the company. The remuneration report is part of the directors' report contained in the annual financial report of the company for a financial year.

The Chair of the meeting must allow a reasonable opportunity for shareholders to ask questions about or make comments on the remuneration report at the annual general meeting.

2.2 Voting consequences

A company is required to put to its shareholders a resolution proposing the calling of another meeting of shareholders to consider the appointment of directors of the company (**Spill Resolution**) if, at consecutive annual general meetings, at least 25% of the votes cast on a remuneration report resolution are voted against adoption of the remuneration report and at the first of those annual general meetings a Spill Resolution was not put to vote. If required, the Spill Resolution must be put to vote at the second of those annual general meetings.

If more than 50% of votes cast are in favour of the Spill Resolution, the company must convene a shareholder meeting (**Spill Meeting**) within 90 days of the second annual general meeting.

All of the directors of the company who were in office when the directors' report (as included in the company's annual financial report for the most recent financial year) was approved, other than the managing director of the company, will cease to hold office immediately before the end of the Spill Meeting but may stand for re-election at the Spill Meeting.

Following the Spill Meeting those persons whose election or re-election as directors of the company is approved will be the directors of the company.

2.3 Previous voting results

At the Company's previous annual general meeting the votes cast against the remuneration report considered at that annual general meeting were less than 25%. Accordingly, the Spill Resolution is not relevant for this Annual General Meeting.

2.4 Board recommendation

Noting that each Director has a personal interest in their own remuneration from the Company as set out in the Remuneration Report, the Board recommends that Shareholders vote in favour of Resolution 1.

3. RESOLUTIONS 2 AND 3 – RE-ELECTION OF DIRECTORS – MR MARK CLARK AND MR MYLES ERTZEN

3.1 Background

The Constitution sets out the requirements for determining which Directors are to retire by rotation at an annual general meeting. Rule 11.7(a) of the Constitution provides that no director may retain office without re-election for more than three years or past the third annual general meeting following the Director's appointment, whichever is the longer.

Mr Mark Clark and Mr Myles Ertzen, having been last elected to the Board on 29 November 2022, will retire in accordance with rule 11.7(a) of the Constitution and ASX Listing Rule 14.4 and being eligible, seek election from Shareholders.

3.2 Qualifications and other material directorships

Mr Mark Clark

B Bus CA

Mr Clark was appointed by the Board as the Executive Chairman of the Company on 8 July 2019.

Mr Clark has over 35 years' experience in corporate advisory and public company management. He was a director of successful Australian gold miner Equigold from April 2003 and was Managing Director from December 2005 until Equigold's \$1.2 billion merger with Lihir Gold in June 2008. Equigold successfully developed and operated gold mines in both Australia and Ivory Coast.

Mr Clark also served as Managing Director of Regis Resources Limited from May 2009 until November 2016 when he was appointed Executive Chairman. He retired as a Director of Regis in October 2018. Mr Clark oversaw the development of Regis' three operating gold mines at the Duketon Gold Project, which culminated in the project producing well over 300,000 ounces of gold per annum.

Mr Clark joined Capricorn in July 2019 and has overseen the successful development and commissioning of the Karlawinda Gold Project and the acquisition and progress of the Mount Gibson Gold Project.

Mr Clark is a member of the Chartered Accountants Australia and New Zealand.

Mr Clark is not an independent director.

During the past three years Mr Clark has not held any other listed company directorships.

Mr Myles Ertzen

B Sc Grad Dip App Fin

Mr Ertzen was appointed by the Board as a Director of the Company on 13 September 2019.

Mr Ertzen was from 2009 until December 2018 a senior executive at Regis having held project and business development roles, culminating in the role of Executive General Manager – Growth from which he resigned in December 2018.

Prior to Regis, Mr Ertzen held a number of senior operations roles for gold mining and development companies and has significant experience in the permitting, development

and operations of gold projects in Western Australia. Mr Ertzen has various regulatory and technical qualifications in mining, management and finance.

Mr Ertzen is an independent director.

During the past three years Mr Ertzen has not held any other listed company directorships.

3.3 Board recommendation

The Board (with Mr Clark abstaining in relation to Resolution 2 and Mr Ertzen abstaining in relation to Resolution 3) supports the election of Mr Clark and Mr Ertzen and recommends that Shareholders vote in favour of Resolutions 2 and 3.

4. RESOLUTION 4 – RATIFICATION OF PRIOR ISSUE OF SHARES

4.1 Background

As announced on 18 March 2025, the Company closed out all of its then remaining 55,000 ounces of gold forward sale hedge contracts with settlement via a bilateral transaction to issue Shares to Macquarie Bank Limited, the Company's hedging and debt financier. As part of the closure and to mitigate the downside risk, the Company also purchased gold put options covering 50% of the volume and the same maturity as the closed hedge contracts.

The cost of the closure, purchase of put options and transaction costs was \$147 million, and was (other than \$7 million paid out of existing cash holdings) funded through the issuance of 17,721,519 Shares at an issue price of \$7.90 per Share (**Prior Issue Shares**).

The Prior Issue Shares were issued under the Company's existing placement capacity under ASX Listing Rule 7.1. Accordingly, Shareholder approval for the issue of the Prior Issue Shares was not required.

Resolution 4 seeks Shareholder ratification pursuant to ASX Listing Rule 7.4 for the issue of the Prior Issue Shares.

4.2 ASX Listing Rules 7.1 and 7.4

Broadly speaking, and subject to a number of exceptions, ASX Listing Rule 7.1 limits the amount of Equity Securities that a listed company can issue without the approval of its shareholders over any 12 month period to 15% of the fully paid ordinary securities it had on issue at the start of that period.

The Prior Issue Shares do not fit within any of these exceptions and, as the issue of these Shares has not yet been approved by the Company's Shareholders, the issue effectively uses up part of the 15% limit in ASX Listing Rule 7.1, reducing the Company's capacity to issue further Equity Securities without Shareholder approval under ASX Listing Rule 7.1 for the 12 month period following the date of issue.

ASX Listing Rule 7.4 allows the shareholders of a listed company to approve an issue of Equity Securities after it has been made or agreed to be made. If they do, the issue is taken to have been approved under ASX Listing Rule 7.1 and so does not reduce the Company's capacity to issue further Equity Securities without Shareholder approval under that rule.

The Company wishes to retain as much flexibility as possible to issue additional Equity Securities into the future without having to obtain Shareholder approval for such issues under ASX Listing Rule 7.1.

To this end, Resolution 4 seeks Shareholder approval to the Prior Issue Shares under and for the purposes of ASX Listing Rule 7.4.

If Resolution 4 is passed, the Prior Issue Shares will be excluded in calculating the Company's 15% limit in ASX Listing Rule 7.1, effectively increasing the number of Equity Securities it can issue without Shareholder approval over the 12 month period following the date of issue.

If Resolution 4 is not passed, the Prior Issue Shares will be included in calculating the Company's 15% limit in ASX Listing Rule 7.1, effectively decreasing the number of Equity Securities it can issue without Shareholder approval over the 12 month period following the date of issue.

4.3 Technical information required by ASX Listing Rule 7.5

Pursuant to and in accordance with ASX Listing Rule 7.5, the following information is provided in relation to the ratification of the issue of the Prior Issue Shares:

- (a) The names of the persons to whom the securities were issued
The Prior Issue Shares were issued to Macquarie Bank Limited (**Macquarie**).
- (b) Number and class of securities issued
17,721,519 fully paid ordinary shares were issued.
- (c) The date on which the securities were issued
The Shares were issued on 18 March 2025.
- (d) Price or consideration at which the securities were issued
The issue price was \$7.90 per Share.
- (e) The purpose of the issue
The Prior Issue Shares were issued to Macquarie as consideration for the closure of gold forward sale hedge contracts, the purchase of gold put options and associated transaction costs, as detailed in section 4.1.
- (f) Summary of any other material terms of the agreement
The material terms of the arrangements between the Company and Macquarie were that the parties agreed that the Prior Issue Shares would be issued to Macquarie as consideration for the closure of gold forward sale hedge contracts, the purchase of gold put options and associated transaction costs, as detailed in section 4.1.
- (g) Voting exclusion statement
A voting exclusion statement is included in the Notice for Resolution 4.

4.4 Board recommendation

The Board recommends that Shareholders vote in favour of Resolution 4.

5. RESOLUTION 5 – APPROVAL OF ISSUE OF PERFORMANCE RIGHTS TO MR MARK CLARK

5.1 Background

Resolution 5 seeks Shareholder approval for the Company to issue of 170,395 Performance Rights to Mr Mark Clark (or his nominee) under the Performance Rights Plan and on the terms and conditions set out below.

The Board is responsible for administering the Performance Rights Plan and the terms and conditions of the specific grants to participants under the Performance Rights Plan. The Performance Rights Plan was last approved by Shareholders at the Company's 2023 annual general meeting. A summary of the material terms of the Performance Rights Plan is set out in Schedule 1.

As an executive of the Company, Mr Clark is entitled to participate in the Company's incentive plans. The Board believes balancing remuneration between fixed remuneration and incentive-based remuneration is an important component of attracting and retaining the best available executive talent. The Board is also cognisant of general Shareholder

opinion that equity-based rewards for staff should be linked to the achievement by the Company of performance conditions.

Accordingly, the Board has determined to offer 170,395 Performance Rights to Mr Clark, which will be subject to the terms of the Performance Rights Plan and the vesting conditions described in section 5.2 below.

5.2 Vesting conditions

The Performance Rights are subject to vesting conditions that are tied to the total shareholder return (**TSR**) of the Company relative to the TSR of the comparator group of companies set out in the table below (**Peer Group**) over a defined period of time (**Measurement Period**).

The peer group is comparable ASX companies. This provides a broad and representative comparative peer group for Australian investors. The peer group will be adjusted if members are delisted (for reasons other than financial failure) or a company merges with or is acquired by another company in the peer group - in which case the resulting company remains in the peer group and the acquired company is removed. The Board has the discretion to adjust the peer group in other circumstances.

TSR is a method of calculating the return shareholders would earn if they held a notional number of shares over a period of time. TSR measures the growth in a company's share price together with the value of dividends during the period, assuming that all of those dividends are re-invested into new shares.

The Measurement Period for 100% of the Performance Rights is the 36 month period commencing on 1 July 2025 and ending on 30 June 2028 (**Performance Rights**).

TSR is calculated by reference to the volume weighted average price of Company shares traded on ASX during the 20 trading days before and including the first trading day of the Measurement Period and the 20 trading days up to and including the last trading day of the Measurement Period.

The proportion of the Performance Rights that vest, if any, will be determined as follows:

Relative TSR for Measurement Period	Proportion of Performance Rights that will vest
Below the 50th percentile	0%
At the 50th percentile	50%
Between the 50th and 75th percentile	Pro-rata between 50% and 100%

5.3 Other terms

Subject to the terms of the Performance Rights Plan, upon the satisfaction of the applicable vesting condition, each Performance Right entitles the holder to one Share. The holder is not required to pay any exercise price to the Company on the vesting or exercise of a Performance Right.

The expiry date of the Performance Rights the subject of Resolution 5 is 31 December 2028.

Performance Rights that do not vest because of either a failure to achieve the vesting conditions or that have not vested by the expiry date will lapse (subject to the terms of the Performance Rights Plan).

5.4 ASX Listing Rule 10.14

Resolution 5 seeks Shareholder approval under ASX Listing Rule 10.14 for the issue of 170,395 Performance Rights to Mr Mark Clark (or his nominee) under the Performance Rights Plan (**PR Issue**).

ASX Listing Rule 10.14 provides that, subject to certain exceptions, a listed company must not permit any of the following persons to acquire equity securities under an employee incentive scheme:

- a director of the company (10.14.1);
- an associate of a director of the company (10.14.2); or
- a person whose relationship with the company or a person referred to in ASX Listing Rules 10.14.1 or 10.14.2 is such that, in ASX's opinion, the acquisition should be approved by its shareholders (10.14.3),

unless it obtains the approval of its shareholders.

The PR Issue falls within ASX Listing Rule 10.14.1 and therefore requires Shareholder approval under ASX Listing Rule 10.14.

Resolution 5 seeks the required Shareholder approval to the PR Issue for the purposes of ASX Listing Rule 10.14.

Shareholders should note that, if Resolution 5 is passed, (i) the Company will be able to proceed with the PR Issue, (ii) approval will not be required under ASX Listing Rule 7.1 in respect of the PR Issue, and (iii) the PR Issue will be excluded from the calculation of the number of equity securities the Company can issue without Shareholder approval under ASX Listing Rule 7.1.

If Shareholders do not pass Resolution 5, the Company will not be able to proceed with the PR Issue. In these circumstances, it will be necessary for the Company and Mr Clark to agree an alternate remuneration structure, which could be an alternate equity proposal to be put to Shareholders and/or an amount of cash.

For the purposes of ASX Listing Rule 10.15, the following information is provided in relation to the PR Issue pursuant to Resolution 5:

(a) The name of the person

The recipient of the Performance Rights will be Mr Mark Clark, or his nominee.

- (b) Category the person falls within and why
The issue of the Performance Rights falls within ASX Listing Rule 10.14.1 because Mr Mark Clark is a Director of the Company.
- (c) The number and class of securities proposed to be issued to the person under the scheme for which approval is being sought
The maximum number of securities that may be issued to Mr Clark, or his nominee, is 170,395 Performance Rights.
- (d) Details of Mr Clark's current remuneration package
Mr Clark's current remuneration package comprises fixed remuneration of \$1,100,000 per annum (plus superannuation benefits).
- (e) The number of securities previously issued to Mr Clark under the scheme and the average acquisition price (if any) paid by Mr Clark for those securities
Since the Performance Rights Plan was last re-adopted at the Company's 2023 annual general meeting, Mr Clark has received the following Performance Rights under the Performance Rights Plan:
- (i) 154,670 Performance Rights with a nil exercise price, as approved by Shareholders in November 2023; and
 - (ii) 153,272 Performance Rights with a nil exercise price, as approved by Shareholders in November 2024.
- (f) Summary of the material terms of the securities, an explanation of why that type of security is being used and the value the Company attributes to that security and its basis
A summary of the material terms of the Performance Rights is set out in sections 5.1 to 5.3 above, with a summary of the material terms of the Performance Rights Plan being set out in Schedule 1.

The Board has determined to issue Performance Rights because the Board considers that the Performance Rights will assist in:
- attracting, motivating and retaining Mr Clark;
 - delivering rewards to Mr Clark for individual and Company performance;
 - allowing Mr Clark the opportunity to increase his shareholding in the Company; and
 - aligning the interest of Mr Clark with those of Shareholders.
- The Company considers that the use of Performance Rights as opposed to other forms of incentive instruments achieves the optimal taxation and financial outcome for both the Company and the executive.

The Company attributes a value of \$1,650,000 to the Performance Rights on the basis of multiplying the number of Performance Rights by the 5-day volume weighted average price of the Company's shares (\$9.68) up to 1 July 2025. No discount has been applied to account for any probability of the vesting conditions having been achieved. The Company has not received an independent valuation in relation to the Performance Rights.
- (g) The date or dates on or by which the Company will issue the securities
If Shareholders pass Resolution 5, the Performance Rights will be issued to Mr Clark or his nominee as soon as practicable after the date of the Meeting and in any event within 3 years of the Meeting. It is anticipated that all Performance Rights will be issued on the same date.

- (h) The price at which the Company will issue the securities to Mr Clark under the scheme
No price will be paid for the Performance Rights upon their issue, nor for the Shares provided upon the exercise of any Performance Right.
- (i) The material terms of the scheme
A summary of the material terms of the Performance Rights Plan is set out in Schedule 1.
- (j) A summary of the material terms of any loan that will be made in relation to the acquisition
There are no loans being made in relation to the acquisition of the Performance Rights.
- (k) Disclosure statement
Details of any securities issued under the Performance Rights Plan will be published in the annual report of the Company relating to a period in which they were issued, along with a statement that approval for the issue was obtained under ASX Listing Rule 10.14.

Any additional persons covered by ASX Listing Rule 10.14 who become entitled to participate in the Performance Rights Plan after Resolution 5 is approved and who were not named in the Notice will not participate until approval is obtained under that rule.
- (l) A voting exclusion statement
A voting exclusion statement for Resolution 5 is included in the Notice.

5.5 Chapter 2E of the Corporations Act

Chapter 2E of the Corporations Act requires that, for a public company, or an entity that the public company controls, to give a financial benefit to a related party of the public company, the public company or entity must:

- obtain the approval of the public company's members in the manner set out in sections 217 to 227 of the Corporations Act; and
- give the benefit within 15 months following such approval,

unless the giving of the financial benefit falls within an exception set out in sections 210 to 216 of the Corporations Act.

The issue of the Performance Rights to Mr Mark Clark constitutes giving a financial benefit as Mr Clark is a related party of the Company for the purposes of the Corporations Act by virtue of being a Director.

The Board (excluding Mr Clark in respect of Resolution 5) has determined that the proposed issue of the Performance Rights the subject of Resolution 5 constitutes reasonable remuneration having regard to the respective position of the Company and Mr Clark, including the duties and responsibilities of Mr Clark in relation to the Company.

Accordingly, the Board (excluding Mr Clark in respect Resolution 5) has determined that the issue of these rights falls within an exception to the need to obtain the approval of the Company's Shareholders for the purposes of Chapter 2E of the Corporations Act.

5.6 Termination benefits

Under section 200B of the Corporations Act, a company may only give a person a benefit in connection with their ceasing to hold a managerial or executive office in the company or a related body corporate if it is approved by Shareholders in accordance with section 200E or an exemption applies. This applies to Mr Clark.

The term 'benefit' has a wide operation and could capture the automatic or accelerated vesting of Performance Rights under the rules of the Performance Rights Plan.

Resolution 5 will therefore also approve, under section 200E of the Corporations Act, any 'termination benefit' that may be provided to Mr Clark under the Performance Rights Plan in relation to the Performance rights contemplated by Resolution 5 in addition to any other termination benefits that may be provided to Mr Clark under the Corporations Act. This may include the early vesting of those Performance Rights (and the receipt of Shares upon exercise of those Performance Rights) if Mr Clark ceases employment with the Company due to death, disability, bona fide redundancy or other reason with the approval of the Board.

The value of such benefits cannot presently be ascertained but matters, events and circumstances that will, or are likely to, affect the calculation of that value include the number of Performance Rights held by Mr Clark prior to cessation of employment, the number that vest and the price of a Share.

5.7 Board recommendation

The Board (other than Mr Clark given his interest in Resolution 5) recommends that Shareholders vote in favour of Resolution 5.

SCHEDULE 1 – SUMMARY OF THE MATERIAL TERMS OF THE PERFORMANCE RIGHTS PLAN

The material terms of the Performance Rights Plan are summarised below.

Unless otherwise defined, capitalised terms in this Schedule 1 have the meaning given to them in the Performance Rights Plan.

- (a) **Eligibility and Grant of Performance Rights:** The Board may grant Performance Rights to any full or part time employee or Director of the Company or an associated body corporate, a casual employee or contractor of a Group Company, or a prospective participant, being a person to whom the Offer is made but who can only accept the Offer if an arrangement has been entered into that will result in the person becoming an Eligible Participant under one of the aforementioned categories (**Eligible Participant**). Performance Rights may be granted by the Board at any time.
- (b) **Consideration:** Each Performance Right issued under the Plan will be issued for nil cash consideration.
- (c) **Conversion:** Each Performance Right is exercisable into one Share in the Company ranking equally in all respect with the existing issued Shares in the Company.
- (d) **Exercise Price and Expiry Date:** The exercise price (if any) and expiry date for Performance Rights granted under the Plan will be determined by the Board prior to the grant of the Performance Rights.
- (e) **Exercise Restrictions:** The Performance Rights granted under the Plan may be subject to conditions on exercise as may be fixed by the Directors prior to grant of the Performance Rights (**Vesting Conditions**). Any restrictions imposed by the Directors must be set out in the offer for the Performance Rights.
- (f) **Renounceability:** Eligible Participants may renounce their offer in favour of a nominee (the Eligible Participants and their nominees are each **Participants**).
- (g) **Lapsing of Performance Rights:** Subject to the terms of the offer made to a Participant, an unexercised Performance Right will lapse:
 - (i) on the Participant ceasing to be an Eligible Participant and:
 - (A) any Vesting Conditions have not been met by the date the Participant ceases to be an Eligible Participant (**Ceasing Date**), unless the Board exercises its discretion to vest the Performance Rights or resolves to allow unvested Performance Rights to remain unvested after the Ceasing Date; or
 - (B) where any Vesting Conditions have been met by the Ceasing Date, the Participant does not exercise the Performance Right within a period of (1) month after the Ceasing Date (or a further date as determined by the Board after the Ceasing Date);
 - (ii) if any Vesting Condition is not satisfied or is unable to be met;
 - (iii) if a Participant engages in hedging or unauthorised dealing of the Performance Right;
 - (iv) if the Board deems that a Performance Right lapses due to fraud, dishonesty or other improper behaviour;
 - (v) if the Company undergoes a Change of Control or a winding up resolution or order is made, and the Performance Rights does not vest; or
 - (vi) the expiry date has passed.
- (h) **Change of Control:** The Board may resolve to waive any of the Vesting Conditions applicable to Performance Rights on a Change of Control occurring, and a Participant will be entitled to exercise any Performance Rights. Otherwise, the Performance Rights will lapse. Further,

the Board may waive any of the Vesting Conditions if a company (**Acquiring Company**) obtains control as a result of a Change of Control and both the Company and the Acquiring Company agree, a Participant may in respect of any vested Performance Rights that are exercised, be provided with shares of the Acquiring Company (or its parent) in lieu of Shares, on substantially the same terms and conditions as the Shares.

For the purposes of the Performance Rights Plan, **Change of Control** means:

- (i) a bona fide takeover bid is declared unconditional and the bidder has acquired a relevant interest in at least 50.1% of the Company's issued shares;
 - (ii) a court approves, under section 411(4)(b) of the Corporations Act, a proposed compromise or arrangement for the purposes of, or in connection with, a scheme for the reconstruction of the Company or its amalgamation with any other company or companies; or
 - (iii) in any other case, a person obtains voting power in the Company which the Board determines, acting in good faith and in accordance with their fiduciary duties, is sufficient to control the composition of the Board.
- (i) **Share Restriction Period:** Shares issued on the exercise of Performance Rights may be subject to a restriction that they may not be transferred, disposed of or otherwise dealt with until a restriction period has expired.
 - (j) **Disposal of Performance Rights:** Performance Rights will not be transferable (except in certain special circumstances with the Board's consent or by force of law) and will not be quoted on the ASX.
 - (k) **Participation:** There are no participating rights or entitlements inherent in the Performance Rights and holders will not be entitled to vote or attend at a meeting of Shareholders of the Company, receive any dividends declared by the Company or participate in new issues of capital offered to Shareholders during the currency of the Performance Rights without exercising those Performance Rights.
 - (l) **Bonus issue:** If Shares are issued pro rata to Shareholders generally by way of bonus issue (other than an issue in lieu of dividends or by way of dividend reinvestment) involving capitalisation or reserves or distributable profits, the number of Performance Rights to which each Participant is entitled, will be adjusted in the manner determined by the Board to ensure that no advantage accrues to the Participant as a result of the bonus issue.
 - (m) **Reorganisation:** In the event of any reorganisation (including consolidation, subdivision, reduction or return) of the issued capital of the Company, the rights of a Participant are to be changed in the manner determined by the Board to ensure that no advantage or disadvantage accrues to the Participant as a result of such corporate action, subject always to the rights of the Participant being changed to the extent necessary to comply with the ASX Listing Rules applying to a reorganisation of capital at the time of the reorganisation.
 - (n) **Change in exercise price:** A Performance Right does not confer a right to a change in exercise price (if any) or a change in the number of underlying Shares over which the Performance Right can be exercised.
 - (o) **Limitations on Offers:** When making an offer of Performance Rights, the Company must have reasonable grounds to believe that the number of Shares to be received on exercise of Performance Rights offered under an offer when aggregated with:
 - (i) the number of Shares that would be issued if each outstanding offer for Shares, units of Shares or options to acquire Shares under the Plan or any other employee incentive plan of the Company were to be exercised or accepted; and
 - (ii) the number of Shares issued during the previous 3 years from the exercise of Performance Rights issued under the Plan,does not exceed 5% of the total number of Shares on issue at the time of the offer.
 - (p) **Amendment:** The Board may, at any time, amend or add to all or any of the provisions of the Performance Rights Plan, an offer made under the plan or the terms or conditions of any

Performance Rights. The Board cannot make an adjustment or variation to the terms of a Performance Right without the Participant's consent if such adjustment or variation would have a materially prejudicial effect on the Participant, other than certain adjustments introduced primarily to comply with applicable laws or regulations (including the ASX Listing Rules), to correct any manifest error or mistake, or to take into account possible adverse tax implications.

- (q) **Winding up:** The Performance Rights do not confer any right to a return of capital and do not confer any right to participate in the surplus profit or assets of the entity upon a winding up.
